Claire also has extensive experience of applications for temporary and permanent leave to remove from the jurisdiction, internal and external relocation cases. She represented the father in the reported appeal [Re H \[2014\] EWCA Civ 989](#) and subsequent rehearing of [Re H \[2015\] EWFC 39](#) concerning an application by the mother to take their child to Iran for a holiday, despite the father's status as a political asylum seeker.

Claire represents clients in all aspects of ancillary relief and matrimonial finance applications. She is particularly experienced in cases involving modest assets where a creative solution is often required to achieve a 'fair' result. She has also represented a number of serving and retired members of the armed forces, and has expertise in pensions.
