Patience has developed a practice within personal injury Small Claims and Fast Track trials and accepts instructions to act on behalf of Claimants and Defendants.

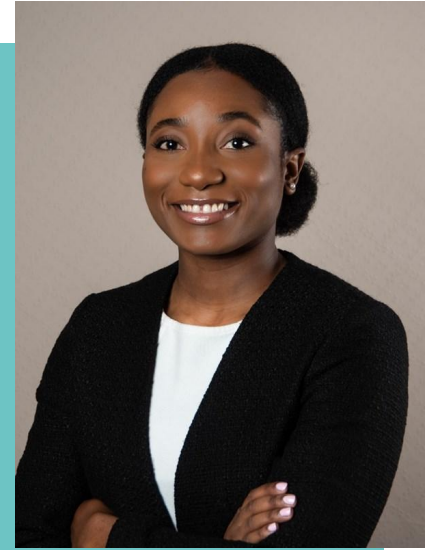
Business & Property
